



INSTRUCTIONS FOR USE

workbenches

Products: Kombi workbenches, modular, mobile – PPS; MPS, workbench accessories



To ensure safe and correct functioning of the products, it is absolutely essential to read these instructions and follow them. Observe the instructions and recommendations mentioned below. Non-observance of principles of safe use may result in injury or harm to the health of operating personnel, damage to the products or their parts, electrical shock, fire or death. Do not use the products under the influence of alcohol or drugs. Do not work with the products if you suffer from giddiness, weakness or faintness. Children must be supervised by adult persons.



Use:

Workbenches are intended for production plants, assembly workshops, laboratories, test rooms, repair shops, training workshops or similar plants. They are suitable for medium to heavy work of a metalworking nature and all places requiring storage or work with heavy objects (tools, instruments, devices) or for special use, such as archiving of documents, mineralogy, etc.

Before workbenches are used, they must be set into the horizontal position. When using workbenches, always strictly observe their maximum permissible load and space layout. It is forbidden to move mobile workbenches with the upper part loaded on an inclined plane or place additional heavy loads on the objects laid on them. Further, it is forbidden to sit or stand on the workbenches or transport persons by means of them. During transport, never leave them unattended; after stopping, secure them against movement. Pull out the drawers only if the workbench cannot start moving spontaneously. When extending drawers provided with a lock against self-extension, unlock the latch first. Heavier objects are preferably to be placed in the lower parts. Immobile products must always be moved empty and only by carrying. Use handling devices to move them.

Weights of individual products, capacities of bearing areas and the hanging system are indicated in the current catalogue of workshop furniture, which can be found at www.polakcz.cz. Do not overload any of the products or their parts, or use them other than for the intended purpose. The total load must not exceed the maximum permissible load of the weakest element of the given product.

It is forbidden to apply greater force on the drawers, doors and roller-shutters than is necessary to open and close them. If the objects laid inside hinder easy closing, rearrange them, never using force. If the drawers are not provided with interlocking, always extend one drawer only. Only lock the cabinet if all drawers are pushed in properly.

The workbenches are not dustproof; therefore, it is necessary to consider their location in plants with increased content of dust particles in the air (joinery workshops, etc.).

For all of the products, only place and use accessories recommended and approved by the manufacturer. It is forbidden to modify the design of the workbenches or accessories. Use them in conformity with safety instructions only. **Electric strips and electric feet can only be connected by qualified personnel. Provide for initial inspection of the electrical equipment, and then for regular inspections according to the legal regulations in force.**

If objects are stored which could damage the surface or individual parts owing to their nature, the workbenches can be protected by additional accessories, such as by using a rubber lining. We recommend that you choose a suitable type of product with regard to its use and operating load in coordination with the seller. Forcible handling may result, for instance, in permanent deformation of metal parts, breakage of a key or a malfunction of extensions.

The workbenches have been designed for interior use, in a dry environment with stable temperature and adequate humidity. Products with the BUK-MASIV and MULTIPLEX worktop must be located in environments with a relative air humidity of 55%, tolerance +/- 5% (during production of the bonded worktop, wood is dried to 8-10% moisture, which corresponds to a relative air humidity of 55%). Using them outside the given range of air humidity causes deformation, which results in the loss of the guarantee. Do not use the products in direct contact with water or in a humid environment. Do not perform manufacturing works which could directly damage their surface or structure unless they are specifically intended for these purposes. Do not expose them to heat sources so that they cannot heat up excessively.

Maintenance:

Maintenance involves the application of lubricant to extensions and other friction surfaces, cleaning the surface of impurities with a wet cloth and subsequent drying. For cleaning, use common cleaning agents for household use, intended for plastic and coated metal surfaces of furniture. Do not clean surfaces of metal parts mechanically; do not use abrasive powder agents, agents based on organic solvents, salts, acids or lyes, which can impair the coated surface.

Product disposal:



The products and packaging materials contain parts which can affect the environment after disposal. At the end of their service life, the created waste must be disposed of in conformity with the legal regulations in force. The product consists of parts which can be sorted and recycled separately.

Guarantee conditions:

The operator is obliged to follow the instructions contained in the user manual. Their non-observance is considered a breach of the guarantee conditions. The guarantee does not cover parts worn due to normal operation.
